If circumstances change during the first 2 years in the home and you can no longer afford the private fees, you or your family may be asked to pay a top-up to any local authority funding you are entitled to receive at that time. If you are unable to afford the top-up, we will do all we can to continue to accommodate you in the home, but we can only guarantee continued residency if the funding meets our fee levels.

Alternatively, we may end your residency with us or require you to move to a less expensive room if one is available. Fee changes To cover inflation and other predictable cost increases, your fees will increase in April each year. Where the date of admission is between 1st January and 31st March in any year the fees will not be increased on 1st April that year, but will instead be reviewed after 6 months and thereafter on 1st April each year. The only other increases payable will be if, upon

assessment, your care needs have changed materially, in which case we will discuss any changes to fees with you as early as possible. Contents insurance
